## ADMISSION TO P G AYURVEDA COURSE- 2023 STRAY VACANCY FILLING ALLOTMENT

The vacancies existing after the Third Round Counselling are to be filled by the respective institutions from **13.12.2023 to 16.12.2023** as per the lists furnished by the Commissioner for Entrance Examinations.

Allotment had been done based on the options registered in the third round allotment by the eligible candidates and the vacancies available published by the CEE, excluding;

- Candidates allotted a seat in the third round irrespective of their joining status.
- Candidates admitted to the course through the phases up to the third round of Centralised Allotments.
- The ineligible candidates, published by the AACCC.

## <u>THREE LISTS HAVE BEEN ISSUED FOR STRAY VACANCY FILLING ROUND OF</u> <u>ADMISSION</u>

<u>Allotment List:</u> Allotment done as per the options registered in the third round counselling. The reporting period is from 13.12.2023 to 14.12.2023, 03.00 PM.

**Probable candidates List:** Candidates to be considered if various vacancies exit after the first list is exhausted. This list is prepared as per the options registered in the third round counseling. The reporting period is from **15.12.2023**, **10.00 AM to 16.12.2023**, **2.00 PM**.

**Eligible candidates List** : If vacancies exist even after the first two lists are exhausted, any candidate satisfying the eligibility conditions mentioned above may be considered for admitting to the remaining Stray Vacancies. In the case of vacancies for which sufficient number of probable candidates are not provided in lists 1 or 2 above, because of lack of

registered options from the candidates eligible to take part in the institutions level stray vacancy allotments, the concerned institutions can straightway consider candidates at this level of priority. The reporting period is from 15.12.2023, 10.00 AM to 16.12.2023, 2.00 PM.

**<u>Reporting Period:</u>** Candidates should report before the concerned college authority with all the documents including TC in original, and the fee should be paid to the college before the end of reporting period. The reporting period of list 1 candidates is from 13.12.2023 to 14.12.2023, 03.00PM and that of list 2 & 3 are from 15.12.2023, 10.00 AM to 16.12.2023, 2.00P.M, based on which the allotment will be done by the college before 16.12.2023, 4.00 P.M.

## **Guidelines for Allotment ( to be followed by the Colleges and candidates)**

1. Stray vacancy filling should **not** be on a First-Come, First-Served basis.

2. Eligible candidates can report before the concerned college authority with all the required documents in original including Transfer Certificate. All the documents listed in the prospectus, as the documents to be submitted to the college authority for taking admission, should be submitted to the concerned college authority before the end of the reporting period.

3. No actual seat allocation should be done before the end of the reporting period, and the admission finalization should be done in rank order only, from the candidates reported before the college authority satisfying the conditions in the previous Para. Admission finalization should be done only after the reporting period ends. Fees collected from candidates who are not finally admitted should be promptly refunded.

4. Admission to any category seat (if any) should be limited to candidates from the respective categories. However, in the event that not enough candidates report during the reporting period, the college authority can convert the category seat to another eligible category as per the prospectus condition. That is, for all the eligible candidates, the reporting period will end at **2.00 PM on 16.12.2023** irrespective of category conversion or not.

5. College authorities should verify the AIAPGET rank details, the State Merit List, as well as the category status of the candidates using the CEE Data Sheet to be brought by the candidates. Academic eligibility should also be verified by the college authority.

6. The colleges should forward the list of Admitted candidates to the CEE on **16.12.2023**, **4:00 P.M**.

- i. The list of candidates who have reported before the college authority.
- ii. The list of rejected candidates, if any, with the reason(s) for rejection.
- iii. The list of candidates finally admitted.
- iv. The vacancy details, if any

The lists should include PG Ayurveda roll number, Kerala state medical rank, admitted category, if applicable, reporting time, and the name of the candidate.

7. All the college authorities should update the details of stray vacancy admission through OAMS before **16.12.2023**, **5:00 P.M** 

Candidates are requested to check the lists the Vacancy details published on the website. Candidates included in the Lists, may contact the college authorities concerned and participate in the allotment process before the stipulated time.
