**LIST PUBLISHED AND FACILITY FOR CORRECTING**  
**DEFECTS IN THE ONLINE APPLICATION**

The Kerala State Provisional Merit List & Category List of candidates who have applied for admission to PG Ayurveda Courses 2024 is published in the website of Commissioner for Entrance Examinations [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The Merit List has been based on the score obtained by the candidates in All India Ayush Post Graduate Entrance Test, AIAPGET 2024. Candidates can view the Provisional Merit List and Category List in the above website. Provisional category list is published based on the claims submitted by the candidates in their online application. If the defects in the certificates uploaded to prove the community reservation are not rectified by the candidates within the stipulated time the provisionally allowed category will be cancelled. The rank of such candidates who do not secured minimum cut-off score in AIAPGET 2024 will also be cancelled.

**FACILITY FOR CORRECTING DEFECTS IN THE ONLINE**  
**APPLICATION**

Candidates who have applied online for admission to the PG Ayurveda Course for the academic year 2024 can view their profile details by entering their Application Number and Password on the page available by clicking on

the link '**PG Ayurveda 2024-Candidate Portal**' in the website, **www.cee.kerala.gov.in**. Candidates can verify details such as Nationality, Nativity, Date of Birth, Communal Reservation, Fee Reservation, Income etc. Those who have defects in their online application shall click the menu '**Memo Details**' available on the Home page and upload the required documents /certificates to correct the defects before **12.00 PM on 25.09.2024**. The required documents should be uploaded online and not to be sent to the Office of the Commissioner for Entrance Examinations. Defects in Nativity given as memo in the candidate portal should also be rectified by uploading valid documents as directed. As per the provisions laid down in the prospectus candidates belonging to the Keralite category alone are eligible for any type of reservation or fee concession. If defects in nativity are not rectified within the stipulated time, reservation claims for such candidates will be cancelled even though they have submitted certificates to prove their reservation claim. No other chance will be provided to rectify the defects in the online application.
