No extension of time for reporting at the college will be granted under any circumstances. The allotted candidates who do not take admission in the CEE/260/2024-TA3 I/143483/2024

respective college before the time specified will lose their present allotment as well as all the existing options. Such candidate will not be considered for further online allotment for the existing options. All the college authority should approve the list of admitted candidates through Online Admission Management System (OAMS) by **5.00 PM on 01.10.2024**

Note: (1) Allotment to Service Quota candidates and PwD candidates have not been done at this phase and will be included in the second phase of allotment.

(2) Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by Screening Committee have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.
