ADMISSION TO PG AYURVEDA DEGREE/DIPLOMA COURSES-2024 **FIRST PHASE ALLOTMENT PUBLISHED**

The first phase of Centralised Allotment for admission to PG Degree/Diploma Ayurveda Courses in the Government/Aided Ayurveda Colleges and in Self financing Ayurveda Colleges for the academic year 2024-25 is published in the website **www.cee.kerala.gov.in**.

To view the allotment result, candidates should log on the '**PG Ayurveda 2024-Candidate Portal**' by submitting their Application Number and Password. By clicking the link '**Allotment Result**', candidates can view their allotment result. The allotment memo is available in the above link and it is necessary to take a printout of Allotment Memo. The candidate who receive an allotment shall remit the fee as specified in the allotment memo at the allotted college. Data sheet also be downloaded from the menu '**Data Sheet**'.

The allotted candidates should report for joining at the allotted colleges before **01.10.2024, 4.00 PM** along with the required document as specified in the Prospectus and in the allotment memo.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated. 20.06.2005. Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

No extension of time for reporting at the college will be granted under any circumstances. The allotted candidates who do not take admission in the

respective college before the time specified will lose their present allotment as well as all the existing options. Such candidate will not be considered for further online allotment for the existing options. All the college authority should approve the list of admitted candidates through Online Admission Management System (OAMS) by **5.00 PM on 01.10.2024**

Note : (1) *Allotment to Service Quota candidates and PwD candidates have not been done at this phase and will be included in the second phase of allotment.*

(2) *Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by Screening Committee have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.*
