This allotment is based on the rank in the Kerala State Merit List & Category list and on the options rearranged/deleted and confirmed by the candidates within the stipulated time.

The allotment result is available in the 'Candidate Portal' on the website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in. To view the allotment result, candidates should log on to the 'PG Ayurveda 2024- Candidate Portal' by submitting their Application Number and Password. By clicking the link 'Allotment Result', candidates can view their allotment results. The Allotment Memo and Data Sheet are available in the Candidate Portal. Candidates are advised to take copies of the Allotment Memo and keep it for future reference, as the Memo will not be available in the Portal once the allotment process is over.

The allotted candidates should report physically for joining at the allotted colleges from 16.10.2024 to 18.10.2024, 4.00PM with the Allotment Memo, Data Sheet and the required documents specified in the Allotment Memo and Prospectus. The prescribed fee should be remitted at the allotted college during admission. Those candidates who do not join the colleges allotted within the stipulated time will lose their allotment and existing options.

The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.
