## ADMISSION TO PG AYURVEDA DEGREE/DIPLOMA COURSES-2024 THIRD PHASE CENTRALISED ALLOTMENT PUBLISHED

The Third Round of Centralised Allotment for admission to PG Ayurveda Degree/Diploma Courses in the Government/Aided Ayurveda Colleges and in Self financing Ayurveda Colleges for the academic year 2024-25 is published in the website **www.cee.kerala.gov.in**.

To view the allotment result, candidates should log on the 'PG Ayurveda 2024-CandidatePortal' by submitting their Application Number and Password. By clicking on the link 'Allotment Result', candidates can view their allotment result. The allotment memo is available in the above link and it is necessary to take a printout of the Allotment Memo. The candidates who receive an allotment shall remit the fee as specified in the allotment memo at the allotted college. Data sheet also be downloaded from the menu 'Data Sheet'.

The allotted candidates should report for joining at the allotted colleges from **04.011.2024 to 06.11.2024**, **4.00 PM** along with the required document as specified in the Prospectus and in the allotment memo.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/ Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated. 20.06.2005. Children of Fisherman/ Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

No extension of time for reporting at the college will be granted under any circumstances. The allotted candidates who do not take admission in the respective college before the time specified will lose their present allotment. Any candidate who is allotted a seat in this phase or any subsequent Stray CEE/260/2024-TA3 1/163968/2024

Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments. Candidates who have already been admitted in PG Ayurveda Course, will lose the existing admission if they get an allotment in this phase. Surrender of seats after Third Round will not be permitted. The registration fee of those candidates who do not join the course if allotted through Third Round will be treated as penalty and will not be refunded. All the college authority should approve the list of admitted candidates through Online Admission Management System (OAMS) by **4.00 PM on 06.11.2024**.

Note: Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.
