ADMISSION TO PG AYURVEDA DEGREE/DIPLOMA COURSES-2024 FIFTH ROUND STRAY VACANCY ALLOTMENT PUBLISHED

The Fifth Round Stray Vacancy Allotment for admission to PG Ayurveda Degree/Diploma Courses in the Government/Aided Ayurveda Colleges and in Self financing Ayurveda Colleges for the academic year 2024-25 is published in the website www.cee.kerala.gov.in.

To view the allotment result, candidates should logon to the 'PG Ayurveda 2024-Candidate Portal' by submitting their Application Number and Password. By clicking on the link 'Allotment Result', candidates can view their allotment result. The allotment memo is available in the above link and the Allotment Memo is required to be produced before the admitting authority of the college to which the candidate is allotted. The candidates who receive an allotment shall remit the fee as specified in the allotment memo at the allotted college. Data sheet also needs to be downloaded from the menu 'Data Sheet' and produced before the admitting authority.

The allotted candidates should report for joining at the allotted colleges from 11.01.2025 to 13.01.2025, 2.00 PM along with the required documents as specified in the Prospectus and in the allotment memo.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/ Candidates eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated. 20.06.2005. Children of Fisherman/ Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

No extension of time for reporting at the college will be granted under any circumstances. The allotted candidates who do not take admission in the respective college before the time specified will lose their present allotment. Any candidate who have an existing admission or who is allotted a seat in this phase irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent Stray Vacancy Filling Allotments, if any.

Conditions

- 1. Those who have already been admitted will not be eligible to participate for further allotments.
- 2. Those who have got allotment in vacant seat allotment/SVR1/SVR2/SVR3/SVR4 will not be eligible to participate for further allotments.
- 3. If any candidate does not join seat allotted in stray vacancy round, he/she may exit with forfeiture of registration fee and cannot participate in further rounds of allotment.
- 4. If a candidate freshly registered in stray vacancy round and is not allotted any seat, he/she is eligible to participate in further stray vacancy round, if any.
- 5. Candidates getting allotment in stray vacancy round shall not have any claim on earlier rounds' allotted seat.
- 6. Any candidate who is allotted a seat in this phase or any subsequent Stray Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments.
- 7. Those candidates who are included in the lists of candidates, ineligible for further rounds of counseling, shared by the AACCC have not been considered for allotment of seats in the stray vacancy filling allotment.
- 8. Those candidates who are blocked from further participation in state quota allotments on account of being admitted in AIQ seat have not been considered in this allotment and are not eligible for subsequent phases of the state admission procedures, and candidates allotted a seat in the third round/stray vacancy round of the All India Counseling have also not been considered for seat allotment and are ineligible to participate in subsequent phases of the state allotments, also.

Surrender of seats after Stray Vacancy Allotment will not be permitted. The

registration fee of those candidates who do not join the course if allotted through Stray Vacancy Allotment will be treated as penalty and will not be refunded. All the college authorities concerned should approve the list of admitted candidates through Online Admission Management System (OAMS) by 3:00 PM on 13.01.2025.

Note: Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to the final decision of the competent authority on their caste status.
