ADMISSION TO PG AYURVEDA DEGREE COURSES-2025

THIRD ROUND ALLOTMENT

Facility for Option Registration Enabled

The third round allotment to PG Ayurveda Courses-2025 will be conducted as per the schedule given below. In this round, afresh option registration facility is available to the candidates. Option registration is a mandatory step of this phase irrespective of whether options were registered or not registered in the previous phases. The options have to be registered through the Online Option Registration facility accessible after logging on to the candidate portal on the website, **www.cee.kerala.gov.in** by giving their Application Number & Password through the link “**PG Ayurveda- 2025 Candidate Portal**”. Then by clicking the Menu ‘**Option Registration**’, candidates can register their options online within the stipulated time.

The schedule for the Third phase allotment is as given below:

Schedule of Allotment

07.11.2025	Online Option registration afresh
10.11.2025, 2.00 PM	Facility for surrender of seats ends
10.11.2025, 4.00PM	Facility for Online registration of options ends.
11.11.2025	Provisional Allotment

12.11.2025	Final Allotment
13.11.2025 to 19.11.2025, 3.00 PM	Joining for allotted candidates
19.11.2025, 4.00 PM	College authorities to approve and submit the list of admitted candidates through the Online Admission Management System (OAMS)

Conditions

1. Those candidates who have not registered in Round I/ Round 2 shall have to pay registration fee for fresh registration.
2. Those who have vacated the seat after **10.11.2025, 2.00 PM** will not be eligible for further round allotments.
3. The options registered in the previous rounds will not be considered for allotment in the 3 round. Hence, candidates shall have to register option afresh if they wish to participate in the third round allotment.
4. If any candidates does not join seat allotted in round 3, he/she may exit with forfeiture of registration fee and cannot participate in further rounds of allotment.
5. Candidates getting allotment in round 3 shall not have any claim on earlier rounds allotted seat.
6. Candidates included in the ineligible list shared by the AACCC after the third round of AACCC allotment will not be considered for the state's third round of allotment or any subsequent phases of the state admission process, even if they have registered options in this phase.
7. The options registered in third round allotment will not be considered for Stray vacancy seat filling.

During this phase, candidates are advised to choose and order their options according to the following conditions.

1. Any candidate who is allotted a seat in this phase or any subsequent Stray

Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments.

2. Candidates who have already been admitted in PG Ayurveda Course, will lose the existing admission if they get an allotment in this phase. Surrender of seats after Third Round will not be permitted.

3. If any candidate already holding a seat allotted in a previous phase wants to quit that seat, the candidate must get TC from the college concerned before **10.11.2025, 2.00 PM** and get it reported by the college to the CEE before **10.11.2025, 3.00 PM**.

4. Candidates can register options (as per the condition mentioned in the prospectus) to any of the courses existing in any of the colleges which the candidate wishes to join irrespective of the existing vacancy position as the seats being vacated as part of the allotment process when candidates already holding a seat allotted to them in a previous phase are re-allotted to a higher option, will also be filled as part of the same allotment process. While registering options, candidates are advised to take into account probable vacancies that may arise due to the applicable category conversion rules also.

5. Any candidate who is allotted a seat in this phase or any subsequent Stray Vacancy Filling Allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments.

6. Candidates who have already been admitted in PG Ayurveda Course, will lose the existing admission if they get an allotment in this phase. Surrender of seats after Third Round will not be permitted.

Registration Fees

Those candidates who have not registered in Round I/ Round 2 shall have to pay registration fee for fresh registration. A registration fee of Rs.2,000/- will have to be paid at the time of Option Registration. Candidates belonging to SC/ST/OEC category eligible for benefits as per

G.O(Ms)No.25/2005/SCSTDD dated:20.06.2005 and G.O (Ms)No.10/20104/BCDD dated:23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechitra Home will have to remit Rs.1,000/- as option registration fee. Registration fess can be remitted by way of online payment.

The registration fee of those candidates who do not get allotment will be refunded. If a candidate gets allotment and does not join within the stipulated time, the option registration fee will be considered as penalty and will not be refunded. Option registration fee of the candidates who quit the seats after taking admission will be considered as penalty and will not be refunded. Refund of option registration fee for the eligible candidates will be made only after the completion of allotment process and it will be notified. Option registration fee will not be adjusted to the course fee and it will be refunded to eligible admitted candidates. The registration fee of candidates, who do not get an allotment will be refunded.

Candidates admitted to the course through previous phases of allotment by the CEE shall be liable for penalty equivalent to the registration fee, if they vacate seats or obtain T.C after **10.11.2025, 2.00 PM**
