ADMISSION TO POST GRADUATE DEGREE COURSES **IN AYURVEDA, KERALA-2025** **APPLICATION SUBMISSION FACILITY RE-OPENED FOR** **STRAY VACANCY ROUND ALLOTMENTS**

The facility to submit fresh online applications for admission to P.G. Ayurveda Degree Courses for the academic year 2025-26 has been re-opened prior to stray vacancy round 1 as per NCISM directives for the academic session 2025-26. Qualified candidates who have not yet registered their online applications can avail this facility from **12.11.2025 to 17.11.2025, 3.00 PM** through the website **www.cee.kerala.gov.in** as per the conditions mentioned in the notification No CEE/178/2025-TA1 dated 13.09.2025.

The Stray Vacancy allotment will be conducted to fill up the available vacant seats after Third Round of allotment and vacancies arising, if any. The net vacant seats after Third Round of allotment will be published later. The fresh applicants, who find a place in the rank list, can participate in the stray vacancy filling allotment, subject to the condition that none of the allotments/admissions carried out in the previous allotments are disturbed.

The candidates who have not submitted applications to the Commissioner for Entrance Examinations for admission to the Post Graduate Degree Courses in Ayurveda can apply online **till 17.11.2025, 3.00 PM** through the website **www.cee.kerala.gov.in**.

Submission of Applications and Application Fee

Qualified candidates who have not yet registered their online applications but seeking admission to the Post Graduate Degree Courses in Ayurveda can apply online **till 17.11.2025, 3.00 PM** through the website **www.cee.kerala.gov.in** of the Commissioner for Entrance Examinations by entering the required AIAPGET 2025 details and then the candidate should remit the required application fee by way of online payment. Candidates

shall upload the candidates' photo and signature, as well as all necessary certificates and documents, after paying the required application fee.

Last date of Application :

Qualified candidates who have not yet registered their online applications but seeking admission to the courses should submit the online application along with uploaded Certificates/Documents mentioned in the prospectus before **17.11.2025, 3.00 PM**. Defective and incomplete applications will be summarily rejected. No correspondence will be undertaken in this regard. Candidates will be allowed, neither to include any information in the application form nor to submit any certificates/documents claiming reservation or any benefits, after the submission of the application. No need to send the printout of the application or any documents to the Commissioner for Entrance Examinations.

Candidates shall submit their options, in the order of their preference for the available Course-College combinations, as and when the facility for

option submission is enabled

Candidate allotted to course, should take admission in the college allotted as per the schedule prescribed by the CEE. Candidate who fails to take admission will lose their allotment as well as the claims for further online allotments, if any. No extension of time for reporting to the college will be granted under any circumstances. The candidates are liable to pay admission fee as prescribed by the University concerned at the time of admission.

Important conditions:

1. Candidates of Kerala origin, except those who have already submitted applications to the Commissioner for Entrance examinations, can submit online options to be considered for allotment to Post Graduate Ayurveda Degree Seats as and when the facility for option submission is enabled. Multiple applications will lead to the cancellation of candidature. However Keralite and Non Keralite candidates can register options to be considered for admission to PG Ayurveda All India Quota/Management seats available in the Self Financing Colleges.
2. Fresh applicants who wish to be considered for admission to various reservation category seats or for any income based fee concessions should submit, along with the online application, the required supporting documents (Community Certificate, Non-creamy Creamy Layer Certificate for State education purpose, EWS certificate, income certificate, etc. as the case may be) to substantiate the claims for reservation or fee concession. There will be no opportunity to submit supporting documents later under any circumstances. Fresh applicants will be considered only against the available reservation categories after the third round of allotment.
3. Candidates who have already applied for PG Ayurveda degree courses and having memo for rectifying defects in the documents for reservation claims can upload valid documents at this time. Those who have defects in their online application shall click the menu '**Memo**

Details' available in 'PG Ayurveda 2025-Candidate Portal' and upload the required documents /certificates to correct the defects on or before 17.11.2025, 03.00 PM

4. Candidates who have already completed their registration but payment was not made can complete the submission of application after paying the required application fees.
5. Service Quota seats are currently not available after third round allotment. Service Quota candidates can submit fresh application but they will be considered only if service quota seats become vacant. Service candidates seeking admission in general quota shall register online options in general category also to be considered for allotment in the quota.
6. PwD seats are currently not available after third round allotment. PwD Quota candidates can submit fresh applications, but they will be considered only if PwD quota seats become vacant.
7. SC /ST/OEC/ Children Fishermen, inmates of Sree Chitra Home, Nirbhaya Home, Juvenile Home candidates are exempted from payment of tuition fee.
8. All candidates are requested to go through the eligibility conditions, academic qualifications, documents required, etc. in the notification No CEE/178/2025-TA1 dated 13.09.2025 and Government approved Prospectus for admission to the Post Graduate Degree Courses in Ayurveda courses available in the website **www.cee.kerala.gov.in** before submission of fresh application.

Candidates allotted to various colleges, should take admission in the colleges and shall remit the fee shown in the Allotment Memo at the college allotted as per the schedule prescribed by the CEE. No extension of time for reporting/joining to the college will be granted under any circumstances.
