ALLOTMENT TO PG MEDICAL (DEGREE) COURSES, KERALA-2023
SCHEDULE FOR FIRST PHASE OF ALLOTMENT
ONLINE OPTIONS INVITED

The activities related to the first phase of centralized allotment to Post Graduate Medical Degree Courses for the year 2023 will commence from **07.08.2023 (Monday)**

All the eligible Candidates included in the Kerala State Merit list who have applied for admission to PG Medical Courses 2023 in the State can register their options online through the Website **www.cee.kerala.gov.in** from **07.08.2023 to 12.08.2023, 5.00PM**.

Candidate shall have to click '**PG Medical 2023-Candidate Portal**' available in the above website and enter their Application Number and Password in order to access their home page. The Candidates can register their options online by clicking the menu item '**Option Registration**' available in the home page.

The schedule for the allotment is given below:

07.08.2023	Opening of the option registration facility.
12.08.2023 5.00 PM	Closing of option registration facility.

The list of Medical Colleges/Courses to which the Commissioner for Entrance Examinations makes allotment is provided in the Home page of the candidate. Candidates can give options as per their priority of the Course-College combinations in the option list. **A candidate need only give options to a Course-College combination if he/she is sure to join the course and college, under the chosen quota, if allotted.** Options registered online alone will be considered for allotment to the courses. Options sent to the Office of

the Commissioner for Entrance Examinations via Post/Fax/E-mail will not be processed /considered for allotment to the courses.

Candidates who seek admission under Minority/NRI quota in Self Financing Medical Colleges shall have to register options online to the desired courses/colleges along with other students during the time of online option registration for first phase itself. Candidates who do not register options shall not be considered for allotment under Minority/NRI quota even if they are included in the respective category lists. Though Minority/NRI quota status of the candidates are not finalized, at this stage, candidates are allowed to choose all the available course-college-quota combination. However, options under NRI and Minority quota will be considered for allotment only if the candidate is found eligible for the respective quota based on the documents uploaded with the online application.

The directions regarding remittance of fees as prescribed, and joining at the colleges for the candidates allotted to courses will be issued later.

The options registered in this phase will be Eligible candidates, who are included in the State Rank List (Kerala Merit List and Service Quota Rank List) prepared by the CEE can register fresh options during the first phase counselling, based on rank and category, allotment will be published. A security deposit of Rs. 10,000/- will have to be paid at the time of option registration, for SC/ST/OE and other candidates who are eligible for fee concession Rs.5000/- will have to be paid as security deposit. Free exit has been offered to all candidates during the first phase of counseling i.e, those candidates, who have got an allotment/admission through first phase state counselling, can leave the seats without paying any penalty. But a candidate who does not join the allotted seat in phase I or who vacates the seat jointed in Phase I will not be considered for phase II allotment. His/her options will be deleted and will only be able to participate in the Mop-up round wherein fresh options are registered. If a candidate gets an allotment and takes admission in the first phase, security deposit will be adjusted to the tuition fee to be paid at the College or if he/she does not get an allotment in this or subsequent phases, this will be refunded after the completion of the entire counselling process.
