NOTIFICATION ADMISSION TO PG MEDICAL COURSES-2023 FIRST PHASE CENTRALISED ALLOTMENT PUBLISHED

The first phase of Centralised Allotment to PG Medical Courses for the academic year 2023-24 in the Government Medical Colleges, RCC Thiruvananthapuram and Private Self Financing Medical Colleges in the State is published in the website www.cee.kerala.gov.in. The allotment is based on the rank in the Kerala State merit list published by Commissioner for Entrance Examinations and online options filed by the candidates from 07.08.2023 to 12.08.2023, 5.00 PM. The allotment has been published after addressing the valid complaints received from candidates against the provisional allotment published on 16.08.2023. The allotment result is available in the website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in.

To view the allotment result, candidates should log on the 'PG Medical 2023-candidate portal' by submitting their Application Number and Password. Then by clicking on the link 'Allotment Result', candidates can view their allotment result. The Allotment Memo will be available in the above link from 17.08.2023 onwards. It is necessary to take a printout of the Allotment memo. Those candidates who receive an allotment shall have to remit the fees as specified in the first phase allotment memo.

The allotted candidates should report for joining the allotted colleges from 18.08.2023 to 21.08.2023, 1.00 PM along with the required documents (as per prospectus clause 10.1.22) specified in the allotment memo. The fee, should be remitted at the allotted college during admission. The fee as shown for courses in

allotments.

dtd.04.07.2023 have to clear the defects on or before the last date fixed by

the Commissioner for Entrance Examinations for option confirmation for the

second phase allotment to PG Medical courses by uploading relevant

documents for clearing the Memo. Those candidates who fail to upload the

documents as specified within the time limit fixed by Commissioner for

Entrance Examinations will lose the allotment, if any, received under NRI

quota in this phase and the Provisional NRI quota claim of the candidate will

also stand cancelled. Any allotment received in NRI quota by such

candidates in this phase will be treated as provisional.

All the college authorities should approve the list of admitted candidates

through Online Admission Management System (OAMS) at 5.00 PM on

21.08.2023.
