ALLOTMENT TO PG MEDICAL (DEGREE) COURSE, KERALA-2023
THIRD PHASE ALLOTMENT- MERIT LIST PUBLISHED &
ONLINE OPTIONS INVITED

The Merit list of candidates applied for PG Medical Courses 2023, as per this office notification dated 22.09.2023 inviting fresh applications based on the revised NEET PG 2023 qualification criteria, are published in the website **www.cee.kerala.gov.in** of the Commissioner for Entrance Examinations.

The option registration facility for the third phase of centralized allotment to Post Graduate Medical Degree Courses for the year 2023 has commenced.

All the eligible Candidates included in the Kerala State Merit list including who have applied for admission to PG Medical Courses 2023 as per this office notification dated 22.09.2023 can register their options online through the Website **www.cee.kerala.gov.in** from **30.09.2023 to 03.10.2023, 5.00 PM**. Those candidates who have already registered options for the third phase allotment, vide notification dated 17.09.2023, can add/ delete/ rearrange the options if they wish to do so.

Candidate shall have to click '**PG Medical 2023-Candidate Portal**' available in the above website and enter their Application Number and Password in order to access their home page. The Candidates can register their options by clicking the menu '**Option Registration**' available in the home page.

The schedule for the allotment is given below:

30.09.2023	Opening of the option registration facility.
03.10.2023 5.00 PM	Closing of option registration facility.

The list of Medical Colleges/Courses to which the Commissioner for Entrance Examinations makes allotment are provided in the Home page of the candidate. Candidates can give options as per their priority of the Course-College combinations in the option list. **A candidate need only to give options to a Course-College combination if he or she is sure to join the course and college under the chosen quota, if allotted.** Options registered online alone will be considered for allotment to the courses. Options sent to the Office of the Commissioner for Entrance Examinations via Post/Fax/E-mail will not be processed /considered for allotment to the courses.

Candidates who seek admission under Minority/NRI quota in Self Financing Medical Colleges shall have to register options online to the desired courses/colleges during the time of online option registration. Candidates who do not register options shall not be considered for allotment under Minority/NRI quota even if they are included in the respective category lists. However, options under NRI and Minority quota will be considered for allotment, only if the candidate is found eligible for the respective quota based on the documents uploaded with the online application.

A security deposit of Rs. 10,000/- will have to be paid at the time of option registration. For SC/ST/OE and other candidates who are eligible for fee concession Rs.5000/- will have to be paid as security deposit. If a candidate gets an allotment and takes admission in this phase, security deposit will be adjusted to the tuition fee to be paid at the College or if he/she does not get an allotment in this or subsequent phases, this will be refunded after the completion of the entire counseling process.

Candidates are required to go through the notification dated 17.09.2023 and provisions in the Prospectus before registering the options. All details related
