ADMISSION TO PG MEDICAL COURSES-2024
FIRST PHASE CENTRALISED ALLOTMENT

PROVISIONAL LIST PUBLISHED

The Provisional allotment list for first phase of Centralised allotment to PG Medical Courses for the academic year 2024-25 in the Government Medical Colleges in the State, Regional Cancer Centre (RCC), Thiruvananthapuram and Private Self Financing medical colleges is published in the website www.cee.kerala.gov.in. The allotment is based on the rank in the Kerala State merit list published by the Commissioner for Entrance Examinations and the online options registered by the candidates from **18.11.2024 to 23.11.2024, 5.00 PM**. The online options registered by candidates whose results have been withheld and of those candidates who have been disqualified based on the Kerala State Merit list have not been considered for allotment. The provisional allotment list is available in the website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in. Candidates can view the allotment list in the '**PG Medical 2024- Candidate Portal**' by submitting their application number and password. Any discrepancy in the Allotment list may be informed to the Commissioner for Entrance Examinations on or before **12.00 Noon of 26.11.2024** through the e-mail ID: ceekinfo.cee@kerala.gov.in. Final allotment will be published after addressing genuine complaints, if any.

***Note:** Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status. Also those candidates, who have uploaded sworn affidavit of sponsor in case of memo for defect rectification in visa validity expired/expiring for NRI claim, have been included provisionally for first phase allotment. Their Allotment/admission in NRI quota seats, if any, will be cancelled if they fail*

to submit the document as prescribed within the stipulated time and will not be considered for NRI seats in further allotment.

The list of participating Medical Colleges in the allotment and the tuition fee applicable to each college have been given in the notification dated 18.11.2024 published in the website.

Candidates are informed that the provisional list is indicative in nature and is subject to change. Allotment to these colleges will be strictly provisional, subject to affiliation/recognition from the KUHS/Government. The allotment to colleges/courses will be subject to recognition of All India Regulatory Bodies/affiliation from the Universities concerned.
