ALLOTMENT/ADMISSION TO PG MEDICAL COURSES-2021

Re-opening of Application Submission Facility following Lowering of the Minimum Qualifying Percentile and Revised Mop Up Schedule

The NEET-PG-2021 minimum qualifying percentiles has been lowered by the National Board of Examinations as per the file no. U-12021/21/2022-MEC dated 12th March 2022, MoHFW as shown in the table below.

Category	Revised Minimum Qualifying Criteria (as directed by MoHFW)	Revised Cut off Score
General(UR/EWS)	35 th Percentile	247
SC/ST/OBC (including PwD of SC/ST/OBC)	25 th Percentile	210
Persons with Disability(UR)	30 th Percentile	229

The online application submission facility based on revised minimum qualifying criteria for PGM-2021 course to State quota seats will be opened from **16/03/2022, 3 PM to 19/03/2022, 10 AM.**

In online application submission, those candidates who are newly qualified as per the revised qualification only can submit applications.

Category	Eligibility for Applying Online as per Revised Minimum Qualifying Criteria
General	Between 35 th Percentile and 50 th percentile
SC/ST/SEBC (including PwD of SC/ST/SEBC)	Between 25 th Percentile and 40 th percentile
Persons with Disability (UR)	Between 30 th Percentile and 45 th percentile

Note:- Those candidates who claim for any community reservation (SC/ST/SEBC) with percentile higher than 40th percentile and lower than 50th percentile and those candidates in PwD category with percentile higher than 45th percentile and lower than 50th percentile will be considered as General Candidates even though they submit the required certificates and documents in proof of their claim online. Such candidates had already been given a chance to apply under the said reserved category by uploading the required documents before 23.01.2022.

Candidates can avail the facility of application submission through the link '**PG Medical 2021 – Re-Opening Online Application**' and should complete the online submission of application and upload the required documents within the deadline. The application facility is hosted on the website www.cee.kerala.gov.in.

Newly qualified candidates, who find a place in the new rank list (prepared by incorporating both the newly qualified candidates and existing candidates in the already published Kerala Merit list), can participate along with the existing candidates, in the remaining phases of allotment subject to the condition that none of the allotments/admission carried out in the previous allotment is disturbed.

The schedule for Mop-up allotment to State quota seats has been modified in accordance with the revision made in the All India Counselling schedule by the Medical Counselling Committee. The revised schedule is as follows:
