**(MSc Nursing)-2024**  
**FIRST PHASE CENTRALISED ALLOTMENT PUBLISHED**

The First Phase of Centralised Allotment for admission to Post Graduate Nursing Courses for the academic year 2024-25 in Government Nursing Colleges and Private Self Financing Nursing colleges in the state is published in the website **www.cee.kerala.gov.in**. The allotment is based on the rank in the rank list of Post Graduate Nursing Courses published by the Commissioner for Entrance Examinations and online options registered by candidates up to **08.10.2024, 5.00 PM**

Candidates can access their home page by entering their application number, and password in the '**PG Nursing 2024-Candidate Portal**' provided in the website. Then by clicking the menu '**Allotment Result**' candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc., are available in the allotment memo and the candidate shall take a print out of the allotment memo. Candidates can log into their Home Page and by clicking the Menu '**Data Sheet**' can download the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges before **15.10.2024, 3.00 PM** along with the allotment memo and original documents specified in Clause 12(C) of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **15.10.2014, 4.00 PM**.

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee

concession as per G.O.(Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/ Children of Fisherman/ Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

The candidates, who do not join the college before the specified date, will lose their present allotment and their higher order options. Their existing options will not be considered for further allotment. The details regarding further allotment will be notified later.
