ALLOTMENT TO P.G (M.Sc) NURSING COURSE 2025 ONLINE OPTIONS INVITED

The Centralised Allotment Process for admission to PG (M.Sc) Nursing Course in Government Nursing Colleges and for Government Merit Seats in Private Self-financing Nursing Colleges of the State for the academic year 2025-2026 has commenced. Candidates (including service candidates) included in the rank list can register their options online through the website www.cee.kerala.gov.in on or before 07.10.2025, 04.00 PM. Candidates may enter their Application Number & Password in the link 'PG Nursing 2025 -Candidate Portal' provided in the above website to log on to their homepage. By clicking the menu 'Option Registration', candidates can register their options online. The first allotment based on the online options received, will be published later.

Option Registration Fee:

Those candidates who wish to register options will have to remit registration fee of Rs.2000/- (Rupees Two Thousand Only) to the Commissioner for Entrance Examinations. Option registration fee will not be adjusted to the course fee and it will be refunded to eligible admitted candidates. Refund conditions for option registration fee is given in clause 12 (vii). Candidates belonging to SC/ST/OEC category eligible for benefits as

per G.O(Ms)No.25/2005/SCSTDD, dated: 20.06.2005 and G.O(Ms)No.10/2014/BCDD, dated:23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sreechithra Home will have to remit Rs.500/-(Rupees Five Hundred Only) as Registration Fee.

A fee prescribed by the Commissioner for Entrance Examinations shall be paid by the candidates at the time of Option Registration. The registration fee once paid will not be allowed to change at any instance. The registration fee can be paid online to the CEE before registering options. The registration fee of those candidates who do not get allotment will be refunded. Registration fees can be remitted **by way of online payment.**

Candidates who fail to register their options online within the stipulated time will not be considered for allotment under any circumstances. Options forwarded to the Commissioner for Entrance Examinations by Email/Post/Hand delivery will not be processed or considered on any account for the allotment of seats.
