ADMISSION TO M.Sc NURSING (PG NURSING) COURSES- 2025 **SECOND PHASE ALLOTMENT PUBLISHED**

The Second Phase of Centralised Allotment (CAP) for admission to Government Nursing Colleges and Private Self-financing Nursing Colleges in the State for the year 2025-26 is published in the website **www.cee.kerala.gov.in**. The allotment is based on the online options confirmed/rearranged/deleted by the candidates within the stipulated time, and rank of the candidate in the Rank List published by the Commissioner for Entrance Examinations.

Candidates can access their homepage by entering their Application number, and Password in the '**PG Nursing 2025- Candidate Portal**' provided in the above website. By clicking the menu '**Allotment Result**', candidates can view Allotment details. Candidate can download their Allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit if any etc., are available in the Allotment Memo. Candidates shall have to take a print out of the Allotment Memo and can log into their Home page and click the Menu '**Data Sheet**' for downloading the Data Sheet.

Candidates who receive fresh allotment or a change in allotment than in the previous phase shall have to take a print out of the Second phase

Allotment memo. Candidates should report for admission before the Principal of the allotted colleges from **16.10.2025 to 18.10.2025, 3.00 PM** along with the allotment memo and original documents specified in Clause 12 (c) of the Prospectus. Candidates who receive fresh allotment or a change in allotment than in the previous allotment should remit the fees or balance fees, if any, as shown in the allotment memo in the allotted college at the time of admission. Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidates eligible for Fee concession as per G.O. (Ms) NO.25/ 2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **18.10.2025, before 4.00 PM**.

Important

1. Candidates who do not take admission within the specified dates and time shall lose their allotment.
2. Candidates who receive a change of allotment to their higher options in the second phase of allotment will automatically lose their current admission of the first phase. If the candidate has a change of college to their higher options in the second phase, they should obtain the T.C, relevant documents submitted at the time of admission from their currently admitted college in the first phase and join the newly allotted colleges within the specified date notified by the Commissioner for Entrance Examinations.
3. Vacancies that exist in various Government and Self Financing Nursing

Colleges after the second phase of Centralized Allotment shall be filled by Mop Up Counseling as per clause 12.A(xix) of P G Nursing Prospectus 2025. Candidates who wish to participate in the Mop Up Allotment shall register their fresh online options through the website of the Commissioner for Entrance Examinations from **17.10.2025 to 21.10.2025, 1.00 PM**. The details of the Mop up Counseling will be published in the website of the Commissioner for Entrance Examinations.
